Royal Warrant of Appointment

This Warrant confirms the appointment of, **Kevin Anthony Allmond**, as an **Ambassador Plenipotentiary**, to the United Kingdom of Great Britain, invested with full power and authority to:

1. Speak for and in of Te Ui Ariki Ngateitei o te Kuki Airani in relation to their Restoration as Sovereign Monarchs and Sovereign Heads of State of the Cook Islands; and to
2. Transact, and or, negotiate any business, finance, and trade, for the benefit, welfare and wellbeing of the Kings and Queens, and the People of the Cook Islands; and to
3. Negotiate Peace and Friendship Treaties, and or, Pacts;

for and in behalf of, Te Ui Ariki Ngateitei o te Kuki Airani, and the People of the Cook Islands (Te Iti Tangata o te Kuki Airani).

This Royal Warrant of Appointment:

1. Shall endure until such time as deemed necessary to enable **Kevin Anthony Allmond**, to complete his tour of duty to the same; and
2. Can be revoked at any time, at the sole discretion of Te Ui Ariki Ngateitei o te Kuki Airani.
